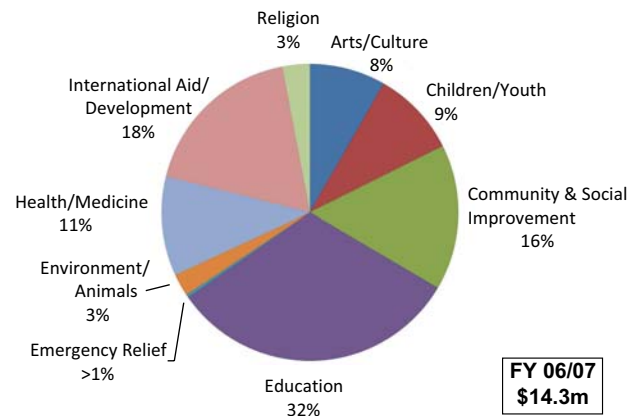

Donor Advised Fund

Establishing a Donor Advised Fund (DAF) with CAFAmerica is a convenient and simple way for all types of US donors to support and manage global philanthropic initiatives. The DAF is designed to support ongoing, high volume programs which require fund management services, including activity statements and online account access. A DAF is also useful for pooling gifts from multiple donors.
