In his last military assignment, he managed a \$170 million investment portfolio of over 300 science and technology projects for the Office of Naval Research.

Its tremendous growth over the last several years is indicative of the trust the philanthropic community has in CAF America as America's global grantmaking organization," said **Bill Zamagni**. "I knew CAF America was the right fit for me as soon as I learned about
